1. Public Forums on the Concerns of People with Disabilities and their Families

Purpose/Goal: To review the testimony from the public forums, identify common concerns and develop recommendations

Meeting Notes:

1. Most of legislation for education already in place
2. Concerns brought forth in forums:
 - a. Children with Autism and parents trying to get what need from the school systems
 - b. Harder to enforce laws for a learning disability
 - c. Laws are not enforced
3. Possibly have conversation with Attorney's General office
 - a. Based on testimony widespread concern about quality of services provided to children with disabilities both in education and group housing
4. There are situations where staffing cut and there was not adequate support
5. Possibly contact Cathryn Sansonetti – Disability Law Center
 - a. Sits on state rehab council
 - b. Has parents coming to talk about school systems
 - c. May have ideas of whether there is any legislative action that needs to be taken
6. Difference between what law requires and what person needs
7. Is there a possibility of amending current law
8. Out of district placement
 - a. Talk to Betty Merner – follow up if the money is being restricted, is it how the funds is being interpreted – Meadowbrook Waldorf school
 - b. Possibly talk to boss
 - c. Law says have to provide out of district placement – does the language in the law need to be more strict
9. RIPIN
 - a. Talk to them about complaints hearing from parents
 - b. May find a trend that can be identified for legislative action
